The Imperial County Adult Education Consortium was established in the spring of 2015, to develop and implement a comprehensive plan to better serve the educational needs of adults in our County. The consortium membership is comprised of the Brawley Union High School District, Calexico Unified School District, Calipatria Unified School District, Central Union High School District, Holtville Unified School District, Imperial County Office of Education, Imperial Unified School District, Imperial Valley Community College District, and San Pasqual Unified School District.

The goal of the Consortium is to, "Enroll, Educate and Employ" the adults in our county. The ultimate goal is to create career pathways for these adults. The Consortium will work together to increase services and provide adults with educational opportunities in the following five program areas:

- Elementary and secondary basic skills, including classes required for a high school diploma or high school equivalency certificate
- Classes and courses for immigrants eligible for education services in citizenship and English as a Second Language and workforce preparation classes in basic skills

- Education programs for adults with disabilities
- Short-term career technical education programs with high employment potential
- Programs for adults, including, but not limited to, older adults, that are primarily designed
 to develop knowledge and skills to assist elementary and secondary school children to
 succeed academically in school.

The Lead Educational Agency (LEA) and Fiscal Agent for the Consortium is the Imperial County Office of Education (ICOE). The primary contacts are April Mazon, Project Coordinator (Lead) and Amanda Brooke, Deputy Superintendent. A part-time Clerical Assistant will be hired as support staff along with two Student Success Specialists whom will serve adult learners across all participating programs/consortium member districts. The Consortium will hold official meetings every other month on the first Wednesday of the designated months. The Consortium is currently exploring systems and possible student tracking methods to be established by the end of 2015-16. By the end of 2017-18 the Consortium expects to see an increase in student enrollment and improved levels of attainment for adult learners in the above mentioned, five focus areas.

6. Programs in career technical education that are short term in nature with high employment potential.



Imperial County Adult Education Needs

The following diagram chart reflects Imperial County adult education needs.




The numbers reflected on the illustration demonstrate the adult education needs in Imperial County. Approximately 63,944 residents of the 175,190 Imperial County population do not have a high school diploma. This Imperial County demographic data was provided by the California Community Colleges Chancellor's Office in 2014 as a guiding tool during the AB 86, Adult Education planning phase.

- **2.3a** Placement of adults (including but not limited to older adults) seeking education and workforce services. (REQUIRED)

A discussion regarding developing adult educational pathways was held during the AB 86 planning grant. It was determined that ESL Pathways, Basic Skills Pathways and Career Pathways would be developed in order to lead adults into workforce placement. Further discussion and planning will continue to happen within the first three years of the block grant. It is the Consortium's goal to have an established Career Pathway's model to support students in a seamless transition to either a Career Technical Program or on a guided pathway to higher education. By the end of the 2017-18 year the consortium foresees the below pathways structure to take root and allow for resources and educational opportunities for adult learners in this area.

The following adult education pathways were developed:



2.3b Programs offering pre-apprenticeship training conducted in coordination with one or

more apprenticeship programs approved by the Division of Apprenticeship Standards. (REQUIRED)

The apprenticeship programs identified for the Imperial County are solely offered at the Imperial Valley Community College (IVC). The On the Job Training (OJT) is coordinated via the Imperial Irrigation District in collaboration with IVC. In order to continue enrollment in the apprenticeship programs, students must submit employment applications to IID. If selected and hired, students are allowed to continue in one of the apprenticeship programs. The Imperial County Adult Education Consortium is not currently focusing on leading efforts in this program area at this time, however, by 2017-18 the Consortium plans to revisit this program area and begin to explore ways to support adults in this area of need.

2.3c Programs for adults (including but not limited to older adults) that are primarily designed to develop knowledge and skills to assist elementary and secondary school children to succeed academically in school. (REQUIRED)

Programs for adults in this area will have resources that will promote support with language development. By assisting adult learners needing their high school diploma and assisting those who also need basic skills, the Consortium will aid adult learners in providing resources for their own children. The expected outcomes are that adult learners will influence their children academically to achieve and assist/encourage their children to set academic goals. As these adult learners become employed and contributing members of society they will be able to offer more resources to their children both educationally and socially. The Consortium has plans of incorporating a series of parenting workshops to support adult learner parents with awareness in College and Career Readiness. The ultimate goal is for these adult learners to be able to better assist their children to navigate through elementary and secondary school and beyond.

2.3d Collection and availability of data. (REQUIRED)

The Consortium is currently exploring various data tracking systems that will respond seamlessly to the current systems at each school district. It is yet to be determined which data tracking source will be decided upon. The Consortium plans to have a current streamlined tracking system in place by 2017-18.

2.3e Qualifications of instructors (including common standards across entities). (REQUIRED)

All Instructors/Teachers will hold an appropriate state issued credential and/or Adult Education credential. They will be certified to teach in classes designed primarily for adults.

Academic content and curriculum are still being explored. The Consortium has yet to decide on what sources will be used to streamline curriculum.
